

New Brighton Club Rules & Regulations

The New Brighton Club and Park facility is for the exclusive use of New Brighton residents and their guests. It is the intent of the New Brighton Residents Association to maximize the safe enjoyment of the facility by all members. In this regard, the following regulations have been established. The New Brighton Residents Association reserves the right to change and add regulations without notice.

MEMBERSHIP

- New Brighton Club fees are mandatory. An encumbrance is registered against the Title of the homeowner.
- The encumbrance fees are due on April 1st of every year and are payable to the New Brighton Residents Association. They may be paid by mail or can be paid directly at the office of the New Brighton Residents Association located at 2 New Brighton Drive S.E..
- A "Member" is defined in the Articles of Association of the New Brighton Residents Association.
- Members will possess a valid membership card to demonstrate that they are in good standing for access to the New Brighton Club.
- Each member MUST present his or her membership card upon entrance to the park.
- Membership cards are not transferable.

ISSUANCE OF NEW BRIGHTON CLUB CARDS

The procedure for obtaining a New Brighton Club card is:

- Bring a copy of your Certificate of Title to the office if you are the registered owner of the property. If renting, a letter is required from the owner indicating that he/she transfers their New Brighton Club privileges to the tenant. Tenants need to bring in their lease agreement to the office.
- Unmarried children, boarders, and nannies that are 21 years of age or older will be issued cards with written consent of the member. They will be required to provide proof of New Brighton residence (i.e. a drivers license) before picture ID is taken.
- New Brighton Club cards are validated every year once fees have been paid. Pictures will be renewed every 3
 years. If a New Brighton Club card is lost or damaged, the resident will be charged \$10.00 for replacement.
- New Brighton Club cards can be issued to members' children who are 12 years of age and over subject to parents' consent
- Membership cards remain the property of the New Brighton Residents Association who may require such cards to be returned if the holder of the card breaches the rules.

GUESTS OF MEMBERS

- Members are permitted a maximum of two (2) guests. If you are planning a large gathering, please make special
 arrangements with the Office Administrator, at least one week prior to the date.
- Members over the age of 12 may take 2 guests or 2 siblings into the facility but not both.
- Members will assume full responsibility for their guests and their guests' actions at all times while in the
 park/facility.
- Guests will not be admitted to the park until the Member has entered the facility.
- Members must be present in the park at all times while their guests are using the facility.
- Residents eligible for membership cannot be signed in as guests.

GENERAL RULES

- The New Brighton Club does not provide supervision or lifeguards for park use. Guardians are responsible for their children at all times. Members and guests use the park facilities at their own risk.
- Members **MUST** have a valid New Brighton Club card in order to enter the park.
- Bicycles are not allowed in the park.
- Animals are not permitted in the park, with the exception of Seeing Eye dogs.
- Alcoholic beverages and glass containers are not permitted in the facility.
- Open fires are not permitted.



- Members are requested to refrain from using foul language in the park. Rambunctious and unsafe behavior will
 not be tolerated.
- Roller-skates, roller blades, and skateboards are not allowed on the hockey/pleasure rink (water park), walkways
 or sidewalks.

TENNIS COURTS

- Tennis courts are to be used for tennis only.
- Soft-soled court shoes are to be used.
- Chairs and other hard objects are not permitted on the courts.
- The courts are available on a first come, first serve basis.
- Use of the courts is to be restricted to 30-minute periods during busy times, except if a formal instruction program
 is scheduled.
- Proper tennis etiquette should prevail to resolve disputes.

VOLLEY BALL COURT

- The court is to be restricted to 30-minute periods during busy times, except if a formal instruction program is scheduled.
- The court is available on a first come, first serve basis.
- Proper etiquette should prevail to resolve disputes.

HOCKEY RINK/PLEASURE RINK/WATER PARK

- People must keep off the ice when resurfacing is in progress.
- Hockey sticks and pucks are <u>not permitted</u> on the pleasure rink.
- People must come out of the water immediately when potentially hazardous conditions exist, such as lightning, high winds, and storms.
- Infants must wear bathing suits and/or a water diaper.
- No food, drink, gravel, sand, garbage, etc. is allowed in the water park.

PROGRAMS

The facility will be reserved for specified programs.

- To participate in a program, you must be a Member or a guest of a member participating in that particular program.
- Guests may participate in programs at an additional cost set forth by the Board of Directors.
- Programs may be opened to non-residents 2 weeks prior to the program beginning.

EQUIPMENT RENTALS

- Members wishing to sign out equipment must leave their New Brighton Club card at the office.
- All equipment must be returned prior to closing.
- Any equipment that is damaged or unsafe should be returned to the office immediately.

FACILITY RENTAL

ANY VIOLATION OF THE ABOVE POLICIES MAY RESULT IN:

A warning by New Brighton Residents Association Management or a suspension of privileges for a period of time that is deemed appropriate.

PLEASE REMEMBER:

In all matters, whether or not specifically covered herein, courtesy and common sense shall prevail. Staff is not provided for supervising or babysitting. Play safe and be respectful of the park and other members in the park. Members are encouraged to approach staff members with any questions or concerns they may have. We will do our best to accommodate you.
